


All regulations and requirements


The Remote Switch Unit VARSU is for use with air curtains and other heaters where remote switching is required. The unit comprises of one 32A double pole and two 20A double pole switches in a surface mounting box, 166mm x 86mm x 40mm deep. The unit is supplied wired for use



## Wiring

All wiring connected to the heater switches and 3-way terminal block should be removed and connections between the 4-way terminal block and the remote switch made as shown in the diagram below. The neutral is not switched. A suitable double pole isolation switch should be incorporated in the circuit.

For safety reasons, a sound earth connection must always be made to the unit before use.
